Series (Session) Objectives:

- 1 Select the best treatment approach through effective assessment of clinical and diagnostic tests, thereby determining patient appropriateness for epilepsy surgery.
- 2 Manage expected patient outcomes following epilepsy surgery.
- 3 Develop the most effective medical and surgical management plan for patients with intractable epilepsy through effective collaboration of multiple disciplines.



In support of improving patient care, Nationwide Children's Hospital is jointly accredited by the American Nurses Credentialing Center (ANCC), the Accreditation Council for Pharmacy Education (ACPE), and the Accreditation Council for Continuing Medical Education (ACCME) to provide continuing medical education for the healthcare team. (2.0 ANCC contact hours; 2.0 CME hours)

Nationwide Children's Hospital has been authorized by the American Academy of PAs (AAPA) to award AAPA Category 1 CME credit for activities planned in accordance with AAPA CME Criteria.
